

Application For Admission To Practice

To appear before The Cherokee Courts, as well as certain administrative agencies such as the Tribal Gaming Commission and the EBCI Cannabis Control Board, an attorney must be admitted to the The Cherokee Bar.

<u>Eligibility:</u> To be eligible for admission to and continuing membership in the The Cherokee Bar, an attorney must:

- Be admitted to the practice of law in North Carolina and remain in good standing with the North Carolina State Bar. Any disciplinary action or status change in the North Carolina State Bar, or any other jurisdiction, must be promptly reported.
- Be knowledgeable, and stay apprised of, federal, state, and Tribal law including the Charter and Governing Document of the Eastern Band of Cherokee Indians, the Cherokee Code, and the Cherokee Rules of Criminal Procedure.

Application Instructions: Upon reviewing the Cherokee Code (*available online on MuniCode*), an attorney seeking admission to The Cherokee Bar must submit a packet containing:

- A completed Application For Admission To Practice.
- An application fee of \$25.00¹ by cash, card, or money order made payable to "The Cherokee Court".
- Proof of current standing with the North Carolina State Bar.

Applicants must also take the prescribed Oath for Admission prior to any Court appearance.
